Bid documents will be issued at the **compulsory briefing meeting** to be held on **18 April 2013** at **Babanango SASSA Offices** at **10:00AM**. Bid documents must be submitted in a sealed envelope clearly marked with the bid number and closing date and, dropped off in the tender box at the SCMU, Ulundi Municipality, Corner Princess Magogo and King Zwelithini Street, Ulundi, 3838 by no later than **12h00 on 03 May 2013** after which bids will be opened at a public meeting at the Finance Boardroom at the same address.

The following documents are mandatory: valid original tax clearance certificate, a certified copy of the most recent municipal account in which the business is registered or operating, Proof of ownership of a roadworthy 7 ton refuse truck in your name or business (log book), copies of ID of members of the entity and certified copy of certificate registration with CIPRO e.g. CK certificates

This bid will be evaluated in terms of the 80/20 Preferential Procurement Point system and the points will be allocated as follows.

80 – Price,
20 - BBBEE

The functionality points (100%) will be evaluated based on proof of ownership of a road worthy 7 ton truck.
